Applications are invited online only by 'One Time Registration' system exclusively from qualified candidates for the under mentioned post. Candidates shall apply only through the online facility provided in the website of Kerala Public Service Commission.

1. Department : Indian Systems of Medicines
2. Name of post : Ayurveda Therapist
3. Scale of pay : ₹ 9940 - 16580/-
4. Number of vacancies : District wise
Malappuram – 1 (One)

Notes:-

- (i) Conventional type applications for the post will be summarily rejected. Candidates shall apply only through online facility available at the Kerala Public Service Commission website viz www.keralapsc.gov.in.
- (ii) A Ranked List will be prepared for Malappuram District in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (iii) Candidates shall submit the application for this post to Malappuram district where the vacancy is in existence and shall note the name of that district against the relevant column in the application.
- (iv) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.1.1961.

Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher

posts when notified.

(v) Persons with Blindness/Low Vision are eligible for 3% appointment as per G.O (P) No 1/13/SJD dt 03.01.2013.

5. Method of appointment : Direct Recruitment
6. Age : 18-36. i.e candidates born between 2.1.1979 and 1.1.1997 (both dates included) only are eligible to apply for this post. Usual age relaxation will be given to SC/ST & Other backward Communities.

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.

- (1) Pass in SSLC or equivalent qualification.
- (2) Pass in Ayurveda Therapist Course conducted by Government of Kerala,

Note :- KS&SSR Part II Rule 10 a (ii) is applicable for selection to this post.

8. Last date of receipt of applications : **16.04.2015** Thursday up to 12 midnight.

9. Mode of submitting applications:-

Candidates must register as per “ ONE TIME REGISTRATION” system on the Official Website of Kerala Public Service Commission viz 'www.keralapsc.gov.in'. Those who have already registered shall apply by logging into their profile using their User ID and pass word. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details on the registration card by clicking the link **Registration Card** after entering the home page. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile and they shall keep in mind the User Id for further communication with the Commission. Application once submitted will be received as provisional and cannot be deleted or altered on after submission. Applications once submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.
