The above vacancies are now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancy earmarked to the above mentioned community, but remains unfilled due to the paucity of candidate and further such vacancy that may occur during the currency of the ranked list published on 06.02.2014 for the post.

Note:-

1) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the service of any of the institutions under its purview if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate, provided that the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

ii) The selection to the concern will be subject to the rules and regulations made from time to time.

5. Method of Appointment : Direct Recruitment
(SC & ST community only)

Note:- Applications of candidates belonging to communities other than those mentioned in this notification will be summarily rejected.

Individual rejection memo will not be sent to them.

6. Age: **18 - 41** .”Only candidates born between 01.01.1996 and 02.01.1973 (both dates included) are eligible to apply for this post.

Note : (i)

The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It should also be clearly specified in the certificate that they were not working in the regular service of the concern.

7. Qualifications

1 Graduation plus a pass in the Intermediate Examination conducted by the Institute of Chartered Accountants of India or a pass in the Intermediate Examinations conducted by the Institute of Cost and Works Accountants of India

OR

A Pass in B.Com in First Class with not less than 3 years experience in Government undertakings in Finance and Accounts Department.

OR

Graduation plus a pass in the SAS (Commercial) Examination conducted by Indian Audit and Accounts Department.

Note: The direct recruitment shall be on probation for a period of two years within a continuous period of three years. They have to pass the Departmental Tests and Account Test (Lower) fixed for Junior Assistants in the Board Service, so as to qualify themselves for declaration of satisfactory completion of their probation.

8. Mode of submitting applications

Candidates shall register as per 'ONE TIME REGISTRATION' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have already registered shall apply by logging on to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link to apply for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove Qualification, experience, community, age etc. have to be produced as and when called for.
