Applications are invited online only from qualified candidates for selection to the under mentioned post in Kerala Government Service. Before applying for the post candidates shall register as per the One Time Registration through the official website of Kerala Public Service Commission.

- 1. Department** : Collegiate Education (Music Colleges)
- 2. Name of Post** : Lecturer in Vocal
- 3. Scale of pay** : Rs.19,240 - 34,500/-
- 4. No. of vacancies** : 13 (Thirteen)

**Note:-** 3% vacancies of the post shall be reserved for Differently abled candidates (Locomotor disability / Cerebral Palsy, Blindness and Low Vision) vide (G.O(P) 61/2012/SWD Dated 17/10/2012).

The above vacancies are now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies noted above, and the vacancies that may be reported to the Commission, during the period of currency of the list.

- 5. Method of appointment** : Direct Recruitment
- 6. Age Limit** : 22-36. Only candidates born between 02/01/1979 and 01/01/1993 (both dates included) are eligible to apply for this post with usual age relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities. (For other conditions regarding age relaxation see para 2 of the General Conditions.

**7 Qualifications** : I or II Class Masters Degree in Vocal or its equivalent from any statutory University / "University and Deemed Universities recognized by the UGC".

- Note:-** 1) Candidates belonging to Scheduled Caste / Schedule Tribe require only 50% marks for the respective Master's Degree whenever such qualification is insisted.
- 2) Candidates who are Ph.D holders require only 50% marks for Masters' Degree if they have acquired the respective Masters Degree prior to 19<sup>th</sup> September, 1991.
- 3) For the post of Lecturer, when qualifications are equal, preference shall be given to those who have studied Malayalam as one of the languages either at Degree level or Post Graduate Level.

**Note:-** Rule 10(a) ii of Part II of KS & SSR is applicable.

### **8. Mode of submitting Applications :**

Before applying for the post, candidates should register as per "ONE TIME REGISTRATION" through the Official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in). Those who have registered shall apply by logging in to their profile using their User-ID and Password. No application fee is required. Candidates can view, rectify defects and have print outs of the details in the registration card by clicking the link **Registration Card** after entering the home page. Candidates are responsible for the correctness of the personal information and secrecy of password and they shall quote the user ID for further communication with the Commission. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected. Documents to prove qualification, age, community etc have to be produced as and when called for.
