**4. Number of vacancies** : 8 (Eight)

The Ranked List prepared in pursuance of this notification is intended to make recruitment to the backlog vacancies earmarked for the various categories of Differently abled Persons as per <u>GO (P) No 7/2011/SWD dated 24/01/2011</u> and will remain in force for a maximum period of three years subject to the condition that the ranked list will cease to exist as and when candidates are advised and appointed against the above mentioned vacancies and also against the backlog vacancies, if any, reported by the Appointing Authorities as earmarked in GO(P) No 7/11/SWD dated 24/01/2011. Rules 14 to 17 of Part II, KS&SSR are not applicable to this selection.

Selection to the above mentioned vacancies will be made from among the Differently abled Persons (Locomotor Disability/Cerebral Palsy, Hearing Impairment, Low Vision) earmarked as per existing Government Orders and vacancies will be apportioned among these categories in the ratio 1:1:1.

5. Method of appointment : Direct Recruitment from among the Differently abled Persons (Locomotor Disability/ Cerebral Palsy, Hearing Impairment and Low Vision) candidates only.

**Note:** - Application submitted by candidate other than those mentioned above will be rejected. Individual rejection memos will not be sent to them.

6. Age limit

- : 1. Hearing Impairment and Low Vision candidates: 18-50. Only candidates born between 02.01.1965 and 01.01.1997 (both dates included) are eligible to apply for the post.
- 2. Locomotor Disability/Cerebral Palsy candidates 18 46. Only candidates

born between 02.01.1969 and 01.01.1997 (both dates included) are eligible to apply for the post.

## 7. Qualifications:

- 1) Pass in SSLC examination or its equivalent qualification and
- 2) Must possess any one of the qualifications mentioned below:
  - a) Lower Grade Drawing Group Certificate KGTE or equivalent
  - b) Second Grade Certificate secured by Draftsman (Civil) Trainees under T.T Scheme, College of Engineering or under Industrial Training Centre conducted by the Ministry of Labour, Government of India after a course 18 months.
  - Building Drawing and Estimating (Higher or Lower) KGTE or equivalent and any two of the other Civil Engineering subjects under KGTE or equivalent
  - d) Diploma in Civil Engineering (2 Years course)of the Women's Polytechnics of the State
  - e) Diploma in Agricultural and Rural Engineering given by the Rural Institute Thavanur.
  - f) Vocational Higher Secondary Course Certificate in Draftsmanship and Quantity Surveying
  - g) Vocational Higher Secondary Course Certificate in Building Technology

**Note:-** KS & SSR Part II Rule 10 a (ii) is applicable.
