Applications are invited Online only by “ONE TIME REGISTRATION” from qualified candidates belonging to reservation group of Scheduled Caste community of Kerala State for appointment in the under mentioned post in Kerala Government Service.

1. **Department** : Ayurveda Medical Education
2. **Name of Post** : Lecturer in Rachana Sharir
3. **Scale of pay** : ₹ 22360-37940
4. **Number of vacancy** : Scheduled Caste – 1 (One)

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the above vacancy earmarked for Scheduled Caste but remain unfilled due to the paucity of candidates during the currency of the existing Ranked list published on 19.03.2014 for the post (Category No. 006/2012, Gazette Date: 16.04.2012)

5. **Method of appointment** : **Direct Recruitment** (From among candidates belonging to the Scheduled Caste community only).

NOTE: 1. Applications of candidates belonging to communities other than Scheduled Caste will be summarily rejected. Individual communication regarding the rejection of their application will not be issued.

2. In the absence of Scheduled Caste candidates, candidates belonging to Scheduled Tribe will also be considered.

6. **Age Limit** : **20-41.** [Only candidates born between 02.01.1975 and 01.01.1996 (both dates included) are eligible to apply for this post. Including relaxation in para 2(i) of the General conditions. For other conditions regarding age relaxations, please see Para (2) except para 2(i) of part 2 of the General conditions.

7. Qualifications

- a) A post Graduate Degree in Ayurveda in the concerned subject, from any of the Universities in Kerala or from any other University recognised by any of the Universities in Kerala.
- b) Permanent “A Class” Registration with Travancore Cochin Medical Council (Council of Indigenous medicines)

Note : i) If post Graduate qualification holders in concerned subjects are not available, the candidates with Post graduate Degree in Sharir/Basic principles shall be admissible.

ii) In the absence of persons with Post Graduate degree in the concerned subject, person with graduation will be considered.

Note : KS & SSR Part II Rule 10 a (ii) is applicable.

8. Probation: Every person appointed to this post shall from the date on which he joins duty be probation for a total period of two years on duty within a continuous period of three years.

9. Mode of submitting Applications:

Candidates must register as per “ONE TIME REGISTRATION” with the Official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply now' button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded should be taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote User-Id for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, Experience, community, age etc have to be produced as and when called for.
