FIRST NCA NOTIFICATION

Applications are invited online only under 'ONE TIME REGISTRATION SCHEME' from qualified candidates belonging to reservation group of community viz Ezhava/Thiyya/Billava in the state of Kerala (communities are noted below) against NCA vacancies for selection to the under mentioned post in Kerala Government Service.

1. **Department** : Medical Education
2. **Name of Post** : Scientific Assistant(Occupational Therapy)
3. **Scale of Pay** : ₹ 18740-33680
4. **Number of vacancies** : Ezhava/Thiyya/Billava-1 (One)

Note:- *The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for the said reserved community as unfilled due to the paucity of candidates during the currency of the Ranked List published on 28.09.2010 (Cat.No.323/2009) for the post.*

5. **Method of appointment** : Direct Recruitment
6. **Age limit** : 18-47, only candidates born between 02/01/1968 and 01/01/1997 (both dates included) are eligible to apply for the post. (including the relaxation mentioned in para 2 (i) of the General Conditions).

(For other conditions regarding age relaxation please See Para 2 of the General Conditions except Para 2 (i))

7. Qualifications:-

- a) **General:-** A Pass in Pre-University or intermediate or any other equivalent examinations.
- b) **Special:-** Diploma in Occupational Therapy of Bombay University or that awarded by the Christian Medical College, Vellore, or by any recognised Universities or recognised Institutions in India.

Note:-*KS&SSR Part II Rule 10(a)ii is applicable.*

- 8. Mode of submitting Application:-** Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to applying for a post. The Photograph uploaded should be one taken on or after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for.
