### **FIFTH NCA NOTIFICATION**

Applications are invited only online from qualified candidates belonging to the following reservation group of communities of Kerala State for appointment in the undermentioned post in Kerala Government Service. The above vacancies are now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the above vacancies earmarked for the above mentioned Community, but remain unfilled due to the paucity of candidates during the currency of the ranked list published on 29.11.2005 for the post (Cat.No.253/2004). This is the Fifth NCA Notification due to the non-availability of candidates for the post as per notifications dated 04.09.2007 (Cat.No.294/2007), 10.09.2008 (Cat.No.325/2008), 15.06.2010 (Cat.No.176/2010) and 31.12.2013 (Cat.No.584/2013, 585/2013 & 586/2013).

- 5 Method of appointment :: Direct Recruitment (From LC, OX, Dheevera Communities only.

**Note:-** Applications submitted by candidates belonging to communities other than the above mentioned communities will be summarily rejected. Individual communication regarding rejection of their application will not be issued.

- 6 Age limit : 18-39. Only candidates born between 02.01.1976 and 01.01.1997 (both dates included) are eligible to apply for the post (including age relaxation as per para 2(i) of the General Conditions)

(For other conditions regarding age relaxation please see Para 2 of the General Conditions) [Except Para 2 (i)]

Candidates who were adult members of SC Community converted to Christianity and their children belonging to OX Community are eligible for age relaxation up to 41 years.

- 7 Qualifications :
  - 1) A pass in SSLC or its equivalent
  - 2) Pass in Dental Hygienist Course conducted in the Dental College, Thiruvananthapuram or its equivalent.

**8. Mode of submitting applications :-**

Before applying for the post, candidates shall register as per 'ONE TIME REGISTRATION' through the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)'. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for applying for a post. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password and they shall keep in mind the User ID for further communication with the Commission. Applications once submitted will be received as provisional and the particulars shall not be deleted or altered after submission. Applications which are submitted not in accordance with the instructions given on the notification and website will be summarily rejected.
