FIRST NCA NOTIFICATION

Applications are invited through online only by **ONE TIME REGISTRATION SCHEME** from qualified candidates belonging to the reservation group of OBC community for selection to the under mentioned post in Kerala Government Service.

1. **Department** : **Public Works/Irrigation**
2. **Name of Post** : **Overseer/ Draftsman Grade II (Electrical)**
3. **Scale of Pay** : **₹ 6680-10790/- (PR)**
4. **Number of vacancies** : **1 (One) OBC**

The above vacancy is now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for OBC community but remain unfilled due to paucity of candidates during the currency of the Ranked List published on 09.02.2010 (Cat.No. 47/2007 Gazette Date: 26.02.2007) for the post.

5. **Method of appointment** : Direct Recruitment (from among candidates belonging to OBC community only).

Note:- *Application of candidates other than OBC community will be rejected and no rejection memo will be issued to them individually.*

6. **Age limit** : **19-39; ie,** only candidates born between 02.01.1976 and 01/01/1996 (both dates included) are eligible to apply for the post. (Including relaxation mentioned in para 2(i) of the General Conditions.)

[For other conditions regarding age relaxations please see Para 2 of the General Conditions, except Para 2 (i)]

7. Qualifications: -

Must possess the following qualifications:

(a) Minimum general qualification of SSLC standard

and

(b) Certificate in Electrical Engineering issued after a course of study of 2 years from an Institution recognized by the Government of Kerala.

OR

National Trade Certificate issued under the Craftsman Training Scheme after 18 months course from the Industrial Training Institutes in the Trade Electrician followed by six months implant training.

OR

MGTE or KGTE Group Certificate in Electrical Engineering-4 subjects viz.,

Light and Power (Higher)

Applied Mechanics (Lower)

Heat Engines (Lower)

Machine Drawing (Lower)

With an experience of not less than 2 years in an Electrical undertaking.

Note:-1 *Experience prescribed for direct recruitment shall be one acquired after obtaining the basic academic or other qualification. Practical Experience gained by holding temporary or regular appointment in Government Service as well as in Public or Registered Private Sector undertaking shall alone be accepted as experience for the purpose of direct recruitment.*

Note:-2. *Temporary or regular appointment in registered Private Sector undertaking shall mean temporary or permanent appointment in*

(i) *Co-operative Societies registered under the Kerala Co-operative Societies Act.*

(ii) *Small Scale Industrial units registered with the Industries Development Commissioner and*

(iii) *Industrial Institutions where in Government have investments.*

Note:-3 *Experience gained as workers on daily wages of a permanent nature shall also be accepted provided the Service is continuous and not of a casual nature.*

Note:-4. *Experience Certificate should be got attested by the concerned Controlling Authority/Administrative Authority of Government. The genuineness of the certificates will be subjected to verification and if found bogus, legal action will be taken against the authorities who issue and the candidates who produce bogus certificate.*

- (c) The Kerala Government Certificate Examination in Electrical Engineering (2 years course) shall be treated as an alternative qualification in lieu of Certificate in Electrical Engineering after undergoing a course of two years in a recognised institution.
- (d) Certificate in Electrical Engineering after a course of study of 2 years from an institution recognized by the Government of Kerala or from any of the Technical Schools recognised by the Government, shall be the certificate issued by the Commissioner for Government Examinations on behalf of the State Board of Technical Education after undergoing a course for 2 years duration therefore and include any one of the following Certificate issued by Government.
 - (i) National Trade Certificate in the trade Electrician issued by the Government of India (National Council for Training in Vocational Trades)
 - (ii) National Trade Certificate issued by the Government under the Craftsman Training Scheme in the Trade Electrician obtained through the Industrial Training Institutes.

- (iii) National Trade Certificate in the trade Lineman and Wireman under the Work Orientation Scheme (Matric Trade) 18 months Course with 6 months. Obligatory implant training issued by Government through Industrial Training Institute for which the minimum general educational qualification for admission was prescribed as completion of University Course intermediate.
- (iv) Any other qualification recognized by the Government as equivalent to anyone of the above Certificates.

Note:- *KS & SSR Part II Rule 10 (a) (ii) is applicable.*

- 8. Mode of submitting Application:** - Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to applying for a post. The Photograph uploaded should be one taken on or after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for.
