FOURTH NCA NOTIFICATION

Applications are invited online only by One Time Registration from qualified candidates belonging to reservation group of community of Kerala State viz Scheduled Caste for selection to the under mentioned post.

1. Department - **Education**
2. Name of Post - **Part Time High School Assistant (Urdu)**
3. Scale of pay - ₹ 9,940– 16,580/-
4. No. of vacancies - District wise

Scheduled Caste – Kannur - 01 (One)

(Fourth Re-notification of the post notified as Category No 170/2010 in Gazette dated 31.05.2010, Category No. 287/2011 in Gazette dated 29.08.2011 and Category No. 96/2014 in Gazette dated 11.04.2014)

- (i) Conventional type applications for the above post will be summarily rejected. Candidates can apply online only on website: www.keralapsc.gov.in.
 - (ii) Applications submitted by candidates belonging to the community other than those notified will be summarily rejected. No rejection memo will be issued to such candidates.
 - (iii) A Ranked list will be prepared for Kannur district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the district.

- (iv) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O(MS) No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (v) Applications shall be submitted to Kannur district only in response to this notification and the name of the district shall be noted in the relevant column of the application.

5. Method of appointment : Direct Recruitment (from candidates belonging to Scheduled Caste Community only). In the absence of Scheduled Caste, candidates belonging to Scheduled Tribe will be considered

6. Age Limit :- 18-45. Only candidates born between 02.01.1971 and 01.01.1998 (both dates included) are eligible to apply for this post. (including the relaxation as per para 2 (i) of the General Conditions).

Note :- For conditions regarding the upper age relaxation, please see para (2) of the General Conditions [except para 2 (I)], subject to the condition that the maximum age limit shall in no case exceed 50 (fifty) years.

7. Qualifications :-

A Degree in Urdu and B.Ed/B.T/L.T conferred or recognized by the universities in Kerala.

OR

A title of Oriental Learning in Urdu awarded or recognized by the Universities in Kerala (if such title has been declared as equivalent to Part III of Degree) and Certificate in Language Teacher's Training issued by the Commissioner for Government Examinations, Kerala.

- Note :-**
1. Candidates possessing post-graduate degree in Urdu are also eligible to apply for the post provided that they have the required training qualification [G.O (Ms) No 177/87/G.Edn dt 22.8.1987].
 2. B.Ed should also be in the concerned subject.
 3. Discipline in which BA/MA/B Ed Degree obtained should be mentioned in the application.
 4. Those candidates who secured B.Ed/B.T Degree from the Universities outside Kerala should note in the application form the number and date of relevant orders recognizing the said degree. The copies of such order shall be produced before the commission when it is called for.

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT :-

- (i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O. (MS) No. 9/78/G.Edn. dated 21.01.1978 to the Wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualification. Soldiers in active service and those working in base establishment are included under the term 'Jawans'. Wives of Jawans should select "Are you entitled to any priority" as 'yes' on online application and give the details in the space following. Such candidates should obtain proper certificates from the Officer Commanding stating the Name, Military Rank and Military Address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).
- (ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O.(MS) No.122/75/G.Edn. dated 27.05.1975 and G.O.(MS) No.50/70/PD dated 12/02/1970).

- (iii) Teachers of the Government Primary and Nursery Schools who are graduates and are otherwise qualified will be exempted from upper age limit [G.O.(MS) No.185/70/Edn. dated 18/04/70 and G.O.(MS) No.466/70/Edn dated 11/11/1970]. They should produce proper certificate from authorities concerned as and when required by the commission.

Note :- Candidates who claim concessions on the basis of above or any of the reason mentioned in para 2 of the General Condition should state “Are you eligible for age relaxation” as “yes” on the online application and give details in the space following. Otherwise the applications are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age (See para 2 of General Conditions).

9. Last date for receipt of applications : **05.10.2016 Wednesday upto 12:00 Midnight.**

10. Mode of Sending Application :-

Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.

11. Address to which applications are to be submitted : www.keralapsc.gov.in.

12. If a Written Test/OMR/Online Test is conducted as a part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
