- (i) Candidates shall apply online only through the website www.keralapsc.gov.in
- (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.
- (iii) The above vacancies are now in existence. Ranked list will be prepared for each district in pursuance of this notification and shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following dates in the following districts as detailed below.

- (iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (iv) Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction, and if she is selected, her name will be removed from the Ranked List and disciplinary action will be taken against her.

5. Method of appointment : **Direct Recruitment** (Only from the communities mentioned above.) [In the absence of candidates belonging to the SC community, applications from Sheduled Tribe Candidates will be considered.]

6. Age : **19-34.** Candidates born between 2.1.1982 and 1.1.1997 (Both dates included) are eligible to apply for this post in the case of Muslim, Viswakarma, SIUC Nadar and Dheevara communities. (Including the relaxation as per Para 2(i) of the General Conditions)

19-36. Candidates born between 2.1.1980 and 1.1.1997 (Both dates included) are eligible to apply for this post in the case of SC community. (Including the relaxation as per Para 2(i) of the General Conditions.

For other conditions regarding age relaxation, please see Para (2) of the General Conditions of the notification.

7. Qualifications:

(1) Must have passed the Plus Two Examination or its equivalent.

Note: Rule 10(a)(ii) of Part II of KS & SSR is applicable.

(2) The minimum height shall be 152 cms, and in the case of candidates belonging to SC community, the minimum height shall be 150 cms.

(3) Eye Sight : Must be certified to possess the visual standards specified below without glasses.

Each eye must have full field of vision, Colour blindness, squint or any other morbid condition of the eyes or lids or either eye will be deemed to be a disqualification
 Medical Certificate from a Medical Officer not below the rank of an Assistant Surgeon/Junior Consultant should be produced at the time of Physical Efficiency Test and should be uploaded in their Profile at the time of Certificate Verification. A format of Medical Certificate is given below.

Note: Details regarding standards of vision should be clearly stated in the Certificate as given above and vague statement such as Vision Normal/good will not be accepted. Specification for each eye should be stated separately. If the specification are not as indicated above, the officer issuing the Certificate should certify whether the candidate has got better standards of vision or worse standards of vision as the case may be, otherwise the Certificate will not be accepted.

- (4). Must be free from apparent physical defects like knock knee, flat foot, varicose vein, bow legs, deformed limbs, irregularities and protruding teeth, defective speech and hearing.
- (5). Must qualify in any five events out of eight events of the National Physical Efficiency Test (One Star Standard Test) as specified below.

*The Physical measurement of candidates will be taken at the time of physical efficiency test and those who do not possess the prescribed physical measurement will not be admitted for the physical efficiency test. **If accidents or injuries happened to a candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test.***

Note:

NCC Cadets having `A' `B' & `C' Certificates will be given weightage marks at the rate of 2%, 3% and 5% respectively (as per GO (MS) No.112/2007/H. Edn dtd 21.8.2007).

8. Mode of submitting application:-

Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission viz., www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using User-ID and password. Candidates must click the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all the requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link 'Applications' in their profile. Candidates are responsible for the correctness of their personal information and the secrecy of password. Before the final submission of the application, candidates must ensure the correctness of the information they have entered. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected for noncompliance with the notification, if found in due course of processing. Documents to prove qualification, Experience, Community, age etc have to be produced as and when called for.

9. Last date for receipt of applications : 02.11.2016 Wednesday upto 12 Midnight.

10. If Written Test/OMR Test is conducted as a part of the selection Admission Tickets for eligible candidates will be made available in their Profile for One Time Registration and the

date of downloading will be included in the Examination Calender. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
