**VII NCA NOTIFICATION**

Applications are invited through One Time Registration Scheme from qualified candidates belonging to reservation groups of under mentioned communities only in Kerala State for appointment in the under mentioned post in Kerala Government Service. Name of the candidates and date of taking the photo should be printed on the photograph. (This is the Seventh NCA notification for the post due to the non-availability of qualified candidates belonging to SC and ST Community notified in the Gazette dated 13.05.2009, 16.04.2010, 31.03.2011, 31.12.2011, 31.01.2013 and 30.11.2013 as per Category Nos 163/09, 93/2010, 30/2011, 547/2011 & 548/2011, 14/2013&15/2013 and 489/13&490/13 respectively)

1. **Department** : **Higher Secondary Education Department**
2. **Name of Post** : **Higher Secondary School Teacher (Junior) - Arabic**
3. **Scale of pay** : **₹ 16,180 – 29,180/-**
4. **Number of vacancies** : **SC – 13 (Thirteen)**      **Category No: 313/2015**  
**ST – 2 (Two)**      **Category No: 314/2015**

The above vacancies are now in existence. The ranked lists published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above communities but remains unfilled due to the paucity of candidates during the currency of the ranked list published for the post with effect from 16.01.2008.

5. **Method of appointment** : **Direct Recruitment** (from candidates belonging to reservation groups mentioned in this notification.) (Applications of Scheduled Tribe candidates will also be considered in the absence of SC candidates and vice versa.)

**Note** The applications of candidates belonging to other than the communities mentioned in this notification will be summarily rejected. Individual rejection memo will not be sent to them.

6. **Age limit** : 20-45. Only candidates born between 02.01.1970 and 01.01.1995 (both dates included) are eligible to apply for the post. (Including relaxations in para 2(i) of the General Conditions) (For other conditions regarding age relaxation, please see Para (2) of the general conditions except Para 2 (i).)

**7. Qualifications:-**

- (1) Master's Degree in the concerned subject with not less than 50% marks from any of the Universities in Kerala or a qualification recognized as equivalent thereto in the respective subject by any of the Universities in Kerala.
- (2) (i) B.Ed Degree in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any of the Universities in Kerala.
- (ii) In the absence of persons with B.Ed. Degree in the concerned subject, B.Ed Degree

acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.

- (iii) In the absence of persons with B.Ed. Degree as specified in item (i) and (ii) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any of the Universities in Kerala
- (3) Must have passed the State Eligibility Test for the post of Higher Secondary School Teachers conducted by Government of Kerala or by the agency authorized by the State Government.

- Note**
- 1 Rule 10(a)(ii) of part II of KS&SSR is applicable.
  - 2 In the absence of B.Ed Degree holders, candidates having Masters Degree with not less than 50% marks and who have passed the State Eligibility Test will be considered. Preference shall be given to those who have acquired Ph.D/M.Phil. Degree or qualified Junior Research Fellowship/National Eligibility Test. The teachers appointed under this provision will have to acquire B.Ed Degree at their own expense within five years from the date of entry in service.
  - 3 Those who have passed Language Teachers Training Course are exempted from acquiring B.Ed. qualification.
  - 4 Persons who have acquired M.Ed. in the subject concerned recognized by a University in Kerala are exempted from B.Ed qualification.

### **Exemptions**

1. Those persons who have passed the State Level Eligibility Test for the post of College Lecturers conducted by Government of Kerala are exempted from passing the State Eligibility Test for Higher Secondary School Teacher.
2. Those persons who have passed National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
3. Persons with Ph.D/M.Phil/M.Ed. degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject should be one awarded by any of the Universities in Kerala or recognized as equivalent thereto by any of the Universities in Kerala.
4. The teachers who have completed 10(ten) years of approved teaching service at the High School level in the General Education subordinate service shall be exempted from passing the State Eligibility Test.

### **8. Mode of submitting Applications:-**

Before applying for the post, candidates shall register as per “ONE TIME REGISTRATION” with the official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in). Those registered can apply by logging into their profile using their user ID and password. No application fee is required. Candidates can view, rectify defects and have printouts of the details on the registration card after entering the Home Page. Candidates are responsible for the correctness of the personal information and secrecy of password and they shall quote the user ID for

further communication with the Commission. Applications which are submitted not in accordance with the instructions given on the website will be summarily rejected. Documents to prove Qualification, experience, age, community etc have to be produced as and when called for by the Commission.
