THIRD NCA NOTIFICATION

Applications are invited (Online only) from qualified candidates of Scheduled Tribe community of Kerala State for appointment in the under mentioned post in Kerala Government service. Before applying for the post the candidate shall register as per One Time Registration Scheme through the official website of Kerala Public Service Commission. This is the third NCA notification for this post due to the non availability of qualified applicants as per the first NCA notification published in the Gazette dated 14.05.2010 as Category Number 151/2010 and the Second NCA notification in the Gazette dated 16.04.2012 as Category Number 74/12.

- 1 Department** : Vocational Higher Secondary Education
2 Name of Post : Non Vocational Teacher in English (Junior)
3 Scale of pay : ₹ 16180-29180
4 Number of vacancies : Scheduled Tribe (ST) – 1 (One)

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above community, but remains unfilled due to the paucity of candidates during the currency of the Ranked list published on 11.07.2007 (Category Number 10/05).

- 5 Method of appointment** : Direct Recruitment (From candidates belonging to ST community of Kerala State only)

Note:- Applications submitted by candidates belonging to communities other than the above mentioned community will be summarily rejected. Individual communication regarding rejection of their application will not be issued.

- 6 Age limit** : 23-45. Only candidates born between 02.01.1970 and 01.01.1992 (both dates included) are only eligible to apply for the post, including the relaxation as per para 2(i) of the General Conditions.

[For conditions regarding other age relaxation, please see Para 2 of General Conditions except Para 2(i)]

7 Qualifications :

- I Post Graduate Degree in English with not less than 50% marks awarded by any of the Universities in Kerala or an equivalent qualification obtained after a regular course of study.

- II
- 1) B.Ed Degree in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by a University of Kerala.
 - 2) In the absence of persons with B.Ed. Degree in the concerned subject, B.Ed.Degree acquired after a regular course of study in the concerned faculty as specified in the Acts and Statutes of any of the universities in Kerala.
 - 3) In the absence of persons with B.Ed. Degree as specified in item (1) and (2) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any of the Universities in Kerala.
 - 4) In the absence of B.Ed. Degree holders, candidates having Masters Degree with not less than 50% marks and who have passed SET will be considered. Preference will be given to candidate having Ph.D or M. Phil or qualified Junior Research Fellowship/NET. The teachers appointed under this provision will have to acquire B.Ed.Degree at their own expense within 5 years from the date of entry in service.
 - 5) Persons who have acquired M.Ed in the subject concerned after a regular course of study and recognized by any of the Universities in Kerala are exempted form B.Ed qualification.
- III
- Must have passed the State Eligibility Test for the post of Non-Vocational Teacher conducted by Government of Kerala or by the Agency authorized by the State Government.

Note: All the educational qualifications for teaching post should be one acquired after a regular course of study from a Recognized University in Kerala or recognized as equivalent thereto by any of the Universities in Kerala.

Exemptions:-

- 1) Those persons who have passed the State Level Eligibility Test for the post of College Lecturers conducted by Govt. of Kerala are exempted from the State Eligibility Test for Non-Vocational Teacher.
- 2) Those persons who have passed the State Eligibility Test for the post of HSST conducted by Government of Kerala are exempted from State Eligibility Test for Non-Vocational Teacher.
- 3) Those persons who have passed National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
- 4) Persons with Ph.D/M.Phil/M.Ed. Degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject be one awarded by any of the Universities in Kerala or recognized as

equivalent thereto by any of the Universities in Kerala.

- 5) Those who have submitted Ph.D Thesis and passed M.Phil shall be exempted from SET, upto the time of exemption granted by the UGC from time to time as in the case of candidates having the above qualifications from passing NET.

Explanation : Non Vocational Teacher (Junior) means post having work load of below 15 period per week per subject.

8. **Probation :** Every person appointed to any of the post shall from date on which he/she joins duty be on probation for a total period of two years on duty within a continuous period of three years.

Note: In case a written examination/OMR test is conducted for this selection, the admission tickets of eligible candidates will be issued through the official website of the Kerala Public Service Commission and the candidates shall download and take print out of the same.

9. Mode of Submitting applications:

Before applying for the post, candidates shall register as per 'ONE TIME REGISTRATION' through the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in'. Those who have registered shall apply by logging in to their profile using his/her User- ID and password. No application fee is required. Candidates can view, rectify defects and have print - outs of the details in the Profile by clicking the link Registration Card after entering the Home Page. Candidates are responsible for the correctness of the personal information and secrecy of password and they shall keep in mind the User ID for further communication with the Commission. Applications once submitted will be received as provisional and the particulars shall not be deleted or altered after submission. Applications which are submitted not in accordance with the instructions given on the website will be summarily rejected. Documents to prove qualification, service, age, community etc. have to be produced as and when called for. For details regarding Photo, ID card etc., refer the General Conditions given in Part II of the Notification
