5. Method of appointment : Direct Recruitment (from candidates belonging to ST only.)

Note: Application submitted by candidates other than those belonging to ST will be rejected. No rejection memo will be issued to them individually.

6. Age Limit: 20-44 as on 01.01.2015

Only candidates born between 02.01.1971 and 01.01.1995 (both dates included) are eligible to apply for this post. (including relaxation in Para 2 (i) of General Conditions).

[For other conditions regarding age relaxation please see part 2 of the General Conditions except para 2(i).]

<u>Note:-</u> Officers of the Technical Education Department, Public Works Department, Public Health Engineering Department, Industries Department, Architecture and Town Planning department may also apply. They will be allowed age relaxation to the extent of their service in those departments. (Maximum age limit shall not exceed 50 years as on 01.01.2015.)

<u>Liability to serve in Defence Services:</u> Persons appointed to the post shall be liable, not withstanding that at the time of requisition they are holding higher appointments, to serve for a minimum period of four years (including period spent in training) in the Defence services or on assignments relating to Defence efforts anywhere in India or abroad, if so required. The liability to serve in the Defence Services will be limited to the first 10 years of service and will not ordinarily apply to persons above 40 years of age.

7. Qualifications:

Degree in Electronics Engineering with not less than 60% marks in the qualifying examination.
