- (ii) Applications submitted by candidates belonging to the community other than those notified will be summarily rejected. No rejection memo will be issued to such candidates.

Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- (iv) Candidates belongings to LC/AI communities should submit application for the post to the District Officer, Kasaragod where the vacancy is existing and should note the name of the District against the relevant column in online application.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O(MS) No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government Service

holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- 5. Method of appointment Direct Recruitment (from candidates belonging Latin Catholic/Anglo Indian community only).
- 6. Age Limit 18-43. Only candidates born between 02.01.1972 and 01.01.1997 (Both dates included) are eligible to apply for this post. [Including the relaxation as per Para 2(i) of General Conditions].

<u>Note:</u>- For conditions regarding other age relaxation please see para 2 of the general conditions, except para 2 (i).

7. Qualifications:-

A degree in the concerned subject and B.Ed/BT/LT in the concerned subject conferred or recognised by the Universitities in Kerala (concerned subjects are specified in Note 3 (a) below.

Notes:-

- 1) Diploma in Rural Service awarded by the National Council for Rural Higher Education will also be treated as equivalent to Degree for the above purpose.
- 2) Candidates should have sufficient knowledge in Kannada which will be tested at the time of interview. If there is a written (Descriptive/OMR) test the Question paper for the test will be in Kannada and the candidates should answer the questions in Kannada.
- 3) (a) The applicant should have taken History or Economics or Geography or Politics or Commerce or Philosophy or Music or Sociology as main subject for Graduation.
 - (b) Graduates in Hindi or Arabic who have taken History as subsidiary for Degree and English and Social Studies for B.Ed are eligible to apply. Trained Graduates in Kannada who have taken English and Social Studies as optional for B.Ed Course from the Karnataka University are eligible to apply for the post.
 - (c)B.A degree with Islamic History Main, General Economics and Political Science (Subsidiaries) and B.Ed in History is also acceptable for the above post (G.O (MS) No. 21/94/G.Edn dated 21.2.1994).
 - (d) Graduates in Islamic History and Arabic main who have taken Social Studies for B.Ed or Graduates in Islamic History (Main) and Indian History and Political Science as subsidiaries and B.Ed with History or Graduates in Islamic History (Main) and Political Science and General Economics as subsidiaries and B.Ed with Social Studies are also eligible to apply for the post as per G.O (MS) No.161/88/G.Edn dated 21.10.1998.
 - (e) Graduates in Islamic History and Urdu double main and B.Ed in Social Studies or Graduation in Islamic History Main, General Economics and Indian History (subsidiaries) and B.Ed in History or Graduates in Islamic History and Arabic Main and B.Ed in History are also eligible to apply for the post (GO (MS) No 254/90/G Edn dated 05.12.1990).
- 4) Post Graduates in concerned subject with B.Ed/BT/LT in the concerned subject are also eligible to apply for the post.

5) Post Title Degree holders are not eligible to apply for this post. Rule 10 (a) ii of Part II of the KS&SSR will be applicable.

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT

(i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated

12.02.1970 and G.O.(MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term `Jawans'. Wives of Jawans should note in the application that they are wives of Jawans. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).

- (ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975).
- (iii) Teachers of the Government Primary and Nursery Schools who are graduates and are otherwise qualified will be exempted from upper age limit (G.O (Ms) No 185/70/Edn dated 18.4.1970 and G.O (Ms) No 466/70/Edn dt 11.11.1970). They should produce proper certificates from authorities concerned as and when required by the Commission.

Note:- Candidates who claim concessions on the basis of above or any of the reason mentioned in para 2 of the General Condition should state "Are you eligible for age relaxation" as "yes" on the online application and give details in the space following. Otherwise the applications are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age (See para 2 of General Conditions).
