1. **Department** : **Legal Metrology**
2. **Name of post** : **Technical Assistant**
3. **Scale of pay** : **₹ 27800-59400/-**
4. **Number of vacancies** : **1 (One)**

The above vacancy is now in existence. 6. **Age Limit** : **19 - 36**

Only candidates born between 02.01.1980 and 01.01.1997 (both dates included) are eligible to apply for this post with usual age relaxation to Scheduled Castes, Scheduled Tribes and other Backward Communities.(For other conditions regarding age relaxation see para 2 of the General Conditions)

7. Qualifications :

A Diploma (Mechanical/Electronics/Applied Electronics/Electronics and Communication/Instrumentation Technology) from a recognised university/Board of Technical Examination awarded after undergoing a regular course of study for not less than three years.

8a) Mode of submitting Applications :

Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission www.keralapsc.gov.in

before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective post in the Notification Link to apply for the post. The Photograph uploaded should be taken after 31/12/2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading the Photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, community etc have to be produced as and when called for.
