**GENERAL RECRUITMENT - STATE WIDE**

**NOTIFICATION (BY TRANSFER)**

Applications are invited Online only from the qualified Ministerial Staff in the Vocational Higher Secondary Education Department. Before applying for the post the candidates should register as per One Time Registration scheme through the official website of Kerala Public Service Commission.

- 1. Department** : Vocational Higher Secondary Education
- 2. Name of post** : Vocational Teacher – Domestic Nursing
- 3. Scale of pay** : ₹ 19,240 - 34,500/-
- 4. Number of vacancy** : 1 (one)

The above vacancy is now in existence. The Ranked list published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancy noted above and that may be reported for recruitment by transfer to the Commission in writing during the period of currency of the list.

- 5. Method of appointment** : Recruitment by transfer (From qualified Ministerial Staff in the Kerala Vocational Higher Secondary Education subordinate service only).

**Note :-** If sufficient number of qualified persons are not available from the ministerial staff such vacancies shall also be filled up by direct recruitment as per G.O.(P) No.80/2004/G.Edn dated 12-03-2004.

- 6. Age limit:-** Must have completed 23 (Twenty three) years as on 01.01.2016. (i.e, only those born on or before 01.01.1993 are eligible). Upper age limit is not applicable. (The conditions regarding the age relaxations in para 2 of the General conditions are not applicable).

**7. Qualifications :-**

Degree in Nursing with not less than 60% marks from any of the Universities in Kerala or an equivalent qualification.

- Note :** (1) In the appointment of Vocational Teacher preference will be given to persons having additional qualification of Diploma in Computer Application from a recognised institution.
- (2) All the Educational Qualifications for teaching posts should be one acquired after a regular course of study from a recognised University in Kerala or recognised as equivalent thereto by any of the Universities in Kerala.
- (3) The rules 14 to 17 of part II of the Kerala State and Subordinate Service Rules 1958 relating to reservation are not applicable to recruitment by transfer.
- (4) The applicant should be a regular Ministerial Staff of the Kerala Vocational Higher Secondary Education Subordinate Service. They should obtain a Certificate from the Head of Office showing their service particulars in the form given as Annexure to the; notification and produce the same as and when required by the Commission.
- (5) Persons appointed through Employment Exchange or otherwise and working on Temporary / Provisional basis are not eligible to apply for the post in response to this notification.
- (6) Every person appointed to the post shall be from the date on which he/she joins duty will be on probation for a total period of two years on duty within a continuous period of three years.
- (7) For appointment the qualified persons in the Ministerial Staff in the Kerala Vocational Higher Secondary Education Subordinate Service shall qualify an eligibility test conducted by the Kerala Public Service Commission.
- (8) Rule 10 a(ii) of Part II, KS & SSR is applicable.

#### **8. Method of submitting Applications :-**

Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be one taken on or after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for.
