1. Department : Industrial Training
2. Name of Post : Junior Instructor (Electrician)
3. Scale of pay : ₹ 13900-24040/-
4. No. of vacancies : 24 (Twenty four)

The above vacancies are now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies noted above and the vacancies that may be reported to the Commission in writing during the period of currency of the list.

6. Age limit : 19 - 44  
Only candidates born between 02.01.1972 and 01.01.1997 (both dates included) are eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities. (for other conditions regarding the age relaxation please see para 2 of the General Conditions)

And
  2. (a) National Trade Certificate in the appropriate trade with 3 years experience in the trade after obtaining the certificate.  
OR  
(b) National Apprenticeship Certificate in the appropriate trade with one year experience after obtaining the Certificate.  
OR  
(c) Diploma in the appropriate branch of Engineering from a Government or Government recognized Polytechnic or its equivalent qualification.

8. **Probation** : Every person appointed shall, from the date on which he joins duty, be on probation for a total period of two years of duty within a continuous period of three years.

There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
