6. Age Limit:

For By transfer : Age shall not exceed 45 years as on 01.01.2015.

For Direct Recruitment : 18-36.

Only candidates born between 02.01.1979 and 01.01.1997 (both dates included) are eligible to apply for this post with usual age relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities (For other conditions regarding age relaxations, please see para 2 of the General Conditions).
