- Proficiency in boat pulling knots, splices and rigging, handling single cylinder motor 2) boat, anchor work and swimming. The proficiency in the above items of work shall be asssessed in a practical test conducted by the Public Service Commisssion at the time of selection.

(Ms) No. 246/70/PD dtd. 21.07.1970 shall be given to candidates who had undergone Seaman training successfully in the Kerala Institute of Nautical Studies, Vizhinjam or similar other training institutions.

Height – Not less than 160 cms. without shoes or boots.

Weight – Not less than 48 kgs.

Chest:- Not less than 78 cms. Normal and not less than 83 cms. on expansion.
