**SPECIAL RECRUITMENT - STATE WIDE**

Applications are invited from qualified Scheduled Caste/Scheduled Tribe candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010 and also bear the name of candidate and the date of photo taken should be recorded in the bottom of the photograph. The uploaded photo will be having a validity of ten years from the date of photograph taken.

- 1 Name of Department** : Excise Department  
**2 Name of post** : Excise Circle Inspector  
(Special Recruitment for SC/ST & ST only)  
**3 Scale of pay** : ₹ 20740 – 36140/- (PR)  
**4 No. of Vacancy** : 3 (SC/ST – 1, ST only – 2)

**Note:** The above Vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Caste/Scheduled Tribe during the pendency of the list. Candidates against vacancies exclusively reported for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list that fresh notification for Scheduled Tribes for vacancies reserved exclusively for them will be issued.

- 5 Method of Appointment** : Direct Recruitment (Special Recruitment from among Scheduled Castes/Scheduled Tribes).

**Note:** Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

- 6 Age** : 19 – 41.  
Only Candidates born between 02.01.1975 and 01.01.1997 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

**Note:** In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (fifty) years.

- 7 Qualifications:** Graduation from any recognized university or any equivalent qualification.

**8 Physical qualification:**

- (a) Height : Must not be less than 160 cms  
(b) Chest : Normal - 81 cms with minimum expansion of 5 cms.  
(c) Must be certified by a Medical Officer not below the rank of Assistant Surgeon as to his physique and fitness and capacity for out door work.

- 9 Training :** Every person appointed to the post by special recruitment shall undergo training for a period of Six months in Police Training College and/or in any other institution as may be prescribed by Government. The period spent on training shall be counted for probation and increment.
- 10** Pay during training period : During the period of training, the candidate shall be paid the minimum of the scale of pay and other allowances attached to the post.
- 11 Probation :** Every person appointed by special recruitment shall, from the date of his joining on training prescribed for the post, be on probation for a total period of 2 years on duty within a continuous period of 3 years.
- 12 Tests :** (a) Every person appointed by special recruitment shall within the prescribed period of probation pass Account Test (Lower), Excise Tests Part A & B and DOM or MOP if he has not already passed them.
- (b) No person shall be eligible for increments in his time scale of pay or on appointment as an approved probationer/as a full member of the service unless and until he has passed the tests specified in sub – rule (a)
- (c) If any person has satisfactorily completed the prescribed period of probation and has passed the tests within the period prescribed by sub-rule (a), his service shall be counted for increments and he shall be deemed to have become an approved probationer/full member of the service on and from the date on which he has completed the period of probation or passed the tests, whichever is later.
- (d) If any person fails to pass any of the test within the period prescribed in para 2 ix (a) of this order, he shall, by order, be discharged from the service.

**13 Mode of Submitting application:**

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be the one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.

- 16** If a written/OMR Test is conducted as part of the selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calender. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will only be permitted to attend the examination.
- 17** Paragraphs two, three and twenty five (except the conditions laid down in the Rule 3 (C) of Part II of the kerala State and Subordinate Service Rules) are not applicable to this selection.
- 18** Appointment are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(MS) No.142/72/PD dated 13.04.1972, G.O.(MS) No. 309/73/PD dated 29.11.1973, G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Castes and Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
