Applications are invited from qualified Scheduled Tribe candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010 and also bear the name of candidate and the date of photo taken should be recorded in the bottom of the photograph. The uploaded photo will be having a validity of ten years from the date of photograph taken.

- 1 Name of Department** : Public Works (Administration)  
**2 Name of post** : Assistant Engineer /Head Draftsman (Civil)  
SR for ST Only  
**3 Scale of pay** : ₹ 11,070 – 18,450 /- (PR)  
**4 No. of vacancy** : 14 (Fourteen)

**Note:-** The above Vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Tribe only during the currency of the list.

- 5 Method of Appointment** : Direct Recruitment (Special Recruitment from among Scheduled Tribes only).

**Note:-** Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

- 6 Age** : 21 – 45.  
Only Candidates born between 02.01.1971 and 01.01.1995 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

**Note:-** In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

**7 Qualifications:**

B.Sc/B.Tech Degree in Engineering (Civil) of the Kerala University.

OR

B.E Degree (Civil) of the Madras University or any other qualification recognized as equivalent thereto.

OR

Associate membership of the Institution of Engineers (India) in Civil Engineering or any other Diploma recognized as equivalent thereto

OR

Pass in Section 'A' and 'B' of Associate membership Examination of the Institute of Engineers India in Civil Engineering.

Liability to serve to the Defence Service:

Persons appointed to the post shall be liable notwithstanding that at the time of requisition of their services they are holding higher appointments to serve for a minimum period of 4 (Four) years (including the period spent on training) in the Defence Service or on assignments relating to Defence efforts anywhere in India or abroad if so required. The liability to serve in the Defence service shall be limited to the first 10 (Ten) years of service and shall not ordinarily apply to persons above 40 (Forty) years of age.

- 8 Probation : Every person appointed to this post shall be on probation from the date on which he joins duty for a total period of two years on duty within a continuous period of three years.
- 9 Test : Assistant Engineers appointed by Direct Recruitment shall pass the Account Test (Lower), The Kerala Public Works Department Manual Test and the Kerala Public Works Department test within the period of probation, if he has not already passed the same.

10 Method of Submitting application:

Before applying for the post, candidates should register as per 'ONE TIME REGISTRATION' Scheme on the official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) . Those who have already registered can apply by logging on to their profile using his/her User-id and password. Candidates shall click on the 'Apply Now' button of the respective post in the Notification link for applying for a post. No application fee is required. Candidates can view, rectify defects and print the details in the profile if required by clicking on the link Registration Card. Candidates are responsible to ensure the correctness of the personal information and secrecy of their password and they shall keep in mind the user id for further communication with the commission. Before applying for a post candidates must ensure the correctness of the information on their profile. They must quote the User-id for further communication with the commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission . Applications which are submitted not in accordance with the conditions given in the notification will be summarily rejected. Documents to prove qualification, age, community etc have to be produced as and when called for.

- 15** Appointment are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
