Note :- (5) Candidates belonging to other backward classes who are required to produce Non Creamy Layer Certificate as per GO(P)NO.81/09/SCSTDD dated 26-09-2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents. SC/ST candidates included in the Short list are required to produce Community certificate issued under rule 4 of Kerala (Scheduled caste and Scheduled tribes) Regulation of issue of Community Certificate rules,2002 by the Revenue Authority.

Note :- (6) Copy of answer scripts of the OMR Test held on **20/02/2015** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
