Note:- (5) The Other Backward Community candidates included in the Short list shall produce Non Creamy Layer Certificate as per G.O.(P) No. 117/08/SCSTDD dated 19-12-2008 or G.O.(P) No.81/09/ SCSTDD dated 26-09-2009. Such candidates in the main list who fail to produce the Non Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as open competition candidates. As regard to such candidates in the supplementary list of Other Backward Classes, their Register Numbers will be deleted from the short list without further notice, if they fail to produce the Non Creamy Layer Certificate. SC/ST Candidates shall produce Caste Certificate obtained from Revenue Authorities not below the rank of Tahsildar as specified in Kerala Gazette, along with other documents.
