Note:- (4) Candidates included in the Short List should present and produce in person the original and self attested copies of documents for verification & interview. Date, Time and Venue of certificate verification & interview will be intimated later.

Note :- (5) SC/ST candidates included in the Short List are required to produce two copies of community certificates issued by the Revenue authority and the candidates belonging to Other Backward Classes who are required to produce Non – Creamy Layer Certificate as per G.O (P) No: 81/09/SC/STDD dated 26.09.2009 shall produce the same along with other documents at the time of verification of original documents.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be found in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on **13/10/2012** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ERXII/10145/2012/EW dated 2-3-2015.**
