Note :- (6) Candidates included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009/G.O (MS) No.5/2014/BCDD dated 31/01/2014 shall produce the same along with the other documents mentioned above at the time of verification of original documents.
