Note :- (6) Candidates belonging to SC/ST Community included in the Short List are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification.Candidates belonging to other backward classes included in the Short List are required to produce Non Creamy Layer Certificate as perG.O.(P)No.81/09/SC/ST/DD dated 26/09/2009 at the time of OTR Verification.
