For the purpose of satisfying the rules of reservation of appointment to Scheduled castes, Scheduled Tribes , Other Backward Classes(and other reserved categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) An Endurance Test will be conducted for the candidates included in the short list . **Date, time and venue will be intimated in due course by SMS/ Profile Message and through electronic and print media.** Candidate should appear in person with their original documents including medical certificate for verification .

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No. 81/09/SC/ST/DD dated 26.09.2009 issued by the concerned revenue authority at the time of OTR Verification.

Note :- (6) Copy of answer scripts of the OMR Test held on **19-05-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (7) No candidates are invalidated as per invalidation Notification No : ER XVI(1) 3220/23/EW dated 22.08.2023.
