Note :- (3) **126 (one hundred twenty six)** candidates who have secured top most marks in the OMR Examination are included in the Main List of this Short list. The marks secured by the last candidate in the Main List is **64.67 (sixty four (point) six seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any), necessary Supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) An endurance Test will be conducted for the candidates included in the Short List. **Date, time and Venue will be intimated in due course by SMS / Profile message.** Candidates should appear in person with their original documents including medical certificate, Non-Creamy Layer Certificate & Community Certificate for OTR Verification.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List are required to produce Non-Creamy Layer Certificate in the case of Other Backward communities, Community Certificate in the case of SC/ST candidates & EWS certificate in the case of Economically Weaker Section issued by the Revenue authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **09-05-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (8) No candidates are invalidated as per invalidation Notification No : ER VI (3)3611/2023/EW dated 04/10/2023.
