For the purpose of satisfying the rules of reservation of appointment to Scheduled Tribes, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification will be published shortly

Note:- (5)According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post

Note :- (6) Candidates included in the Probability List are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (7) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice

Note :- (8) Copy of answer scripts of the OMR Test held on **17-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
