Note:-(7) Candidates included in the Short List are required to produce Community Certificate (in form III / Digitally Signed Certificate) issued by the Competent Revenue Authority not below the rank of Tahsildar as specified in Kerala Gazette at the time of Verification.

Note:-(8) Copy of answer scripts of the OMR Test held on **02-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
