Note :- (8) SC/ST Candidates included in the Short List are required to produce Community Certificate in Form III/Digitally signed and candidates belonging to other Reservation groups are required to produce Non Creamy Layer certificate as per G.O (P) No.81/2009/SC/STDD dated 26.09.2009 or EWS certificate,as applicable issued by the Revenue authority at the time of OTR Verification.
