Note :- (3) 10 (Ten) candidates who have secured top most marks in the OMR examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **42.33 (forty two (point) three three)** Marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date, time and Venue of both will be published shortly.**

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) SC/ST Candidates included in the Short List are required to produce Community Certificate (in Form III /Digitally signed) issued by the concerned Revenue authority, candidates belonging to Other Reservation Groups should produce Non Creamy Layer Certificate and those who claimed EWS should produce relevant certificate issued by Village Officer at the time of OTV.

Note :- (8) Copy of answer scripts of the OMR Test held on **04-05-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Answer Scripts of no Candidates are invalidated as per Notification No : ER VI (3) 2403/2023/EW dated 27.07.2023
