Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates included in the Short List, eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009/ Community Certificate / EWS Certificate as per G.O.(MS) No.02/2020/P&ARD dated 12/02/2020 issued by the Revenue authority at the time of OTR Verification.

Note :- (6) Copy of answer scripts of the OMR Test held on 07-06-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification No: ER II (2) 3284/2023/EW dated 07.09.2023.
