Note :- (5) Candidates included in the Short List are required to produce Community Certificate/Non Creamy layer Certificate as per G.O (P) No.81/2009/SC/ST/DD dated 26.09.2009 and those belong to EWS category are required to produce EWS Certificate in the format prescribed vide G.O(MS)No:02/2020/P&ARD dated 12.02.2020 in proof of their claim along with other relevant documents at the time of One Time Verification of original documents.

Note:- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) For Online Examination, rachecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked list. Detailed instructions will be furnished in the Ranked List to be published for the post.
