The marks secured by the last candidate in the Main List is **64 Marks(Sixty Four Marks)** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Cates, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) Candidates included in the Short List should present in person for Endurance Test. **Date,time and Venue** of Endurance Test will be intimated later

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) SC/ST Candidates included in the Short List are required to produce Community Certificate (in FormIII/Digitally signed) issued by the concerned Revenue authority.Candidates belonging to Other Backward Classes should produce Non Creamy Layer Certificate and those who claimed EWS should produce relevant EWS certificate issued by Village Officer at the time of OTR Verification.

Note :- (6) Copy of answer script of the OMR Test held on **09-05-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note:-(7) Answer Script of no candidate is invalidated as per Notification No :ERXVI(3)3611/2023/EW dated 04.10.2023. .
