Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) **20 (Twenty)** candidates who have secured top marks in the OMR Examination are included in the Main List of the Short List. The marks secured by the last candidate in Main List is **78 (Seventy eight) marks**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes & Economically Weaker Section, necessary supplementary List is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (3) The Short list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for Verification and Physical Measurement. . **Date,time and Venue of Physical Measurement and OTR Verification will be published in due course.**

Note:- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) SC/ST candidates included in the Short list are required to produce Community Certificate (in Form III / Digitally Signed) issued by the concerned Revenue Authority. Candidates belonging to Other Backward Classes should produce Non Creamy Layer Certificate and those who claimed EWS should produce relevant certificate issued by the Village Officer at the time of OTV.

Note :- (8) Copy of answer scripts of the OMR Test held on **17-05-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification No : .ERXVI(3)3634/23/EW Dated 19/09/2023.
