Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) 10 (Ten) candidates who have secured top most marks in the OMR examination are included in the Main List of Short List. The marks secured by the last candidate in the Main List is **29.67 (twenty nine (point) six seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be intimated in due course.**

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer and SC/ST candidates, included in the List, are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS certificate vide GO (M S) No 2/2020/P&ARD dated 12-02-2020 issued by the Revenue Authority, along with other documents at the time of OTR verification.

Note :- (6) Copy of answer scripts of the OMR Test held on **07-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (7) No answer scripts are invalidated as per Notification No. **ER II(2) 3284/23/EW** dtd **07.09.2023**.
