Note :- (2) **73 (Seventy Three)** candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Shortlist. The marks secured by the last candidate in the Main List is **56.33 (fifty six (point) three three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribe, Other Backward Classes and other reserved categories, necessary supplementary lists is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes

Note :- (3) Candidates included in the Short List should be present in person and produce the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

Note :- (4) Candidates included in the Short List ,eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009 / Community Certificate/ EWS Certificate issued by the Revenue authority and shall produce the same along with the other documents at the time of verification of original documents.

Note :- (5) The Short List is prepared based on the details furnished by the candidate in the application for the post and subsequent claims made will not be entertained at any stage.

Note :- (6) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **07-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ERXIV(1)3609/2023/EW dated 25.10.2023
