The marks secured by the last candidate in the main list is 48.67 (Forty eight (point) six seven) Marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories, if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present in person for Physical measurement and Physical efficiency test. Date, Time and Venue of Physical measurement and Physical efficiency test will be intimated through SMS, Profile Message and through Print and Electronic Media. The shortlisted candidates should download their admission tickets for the Physical measurement and Physical efficiency test from their OTR profiles logging on to the official website -www.keralapsc.gov.in of the Kerala Public Service Commission and appear for the test with necessary documents.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this list are required to produce Non-Creamy Layer Certificate as per GO(P)No:81/09/SC/STDD dated 26.09.2009 and SC/ST candidates included in this list are required to produce Community Certificate in Form III or digitally signed by the Revenue Authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Section (EWS) included in this List are required to produce certificate issued by the competent Revenue authority along with the other documents at the time of verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on 05-09-2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidates are invalidated vide Invalidation Notification No: ER XVI(1)4674/2022/EW Dated 30.12.2022.
