Note :- (3) Candidates included in the Short List should present and produce in person the original documents for OneTime Verification. Date,time and Venue of OTR Verification will be intimated shortly.

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates included in the Short List ,eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009. SC/ST candidates included in the Short List are required to produce Community Certificate(Form III / Digitally Signed) issued by the competent Revenue Authority and those belonging to Economically Weaker Section Category are required to produce EWS certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim alongwith other relevant documents

Note :- (6) Copy of answer scripts of the OMR Test held on 02.06.2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of of the Ranked List. No Candidates are invalidated as per Notification No: ER VII (2) 3258/2023/EW dated 04.09.2023.
