The marks secured by the last candidate in the Main List is **55 (fifty five)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any), necessary Supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be intimated in due course.**

Note :- (5) The Short list is prepared based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note :- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) Candidates belonging to other backward classes included in the Short List are required to produce Non Creamy Layer Certificate, SC/ST candidates are required to produce community certificates in Form III or digitally signed issued by Revenue Authority and candidates belonging to Economically Weaker Section (EWS) included in this list are required to produce certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (8) For Online examination, rechecking and revaluation are not allowed but print out of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of the Ranked List. Detailed instruction will be furnished in the Ranked List to be published for the post.
