Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (5) Candidates belonging to Other Backward Classes included in the Short List are required to produce NonCreamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification. EWS Certificate issued by the Revenue authority should be produced by the candidates belonging to Economically Weaker Sections at the time of OTR Verification.

Note :- (6) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
