Note :- (2) 52(Fifty Two) candidates who have secured top most marks in the OMR examination are included in the Main list of this Probability List.The mark secured by the last candidate in the main list is 77.33 (Seventy Seven(point) Three Three) marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste,Scheduled Tribe,Other Backward Classes(and other reserved categories if any) necessary supplementary lists is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (3) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date, time and venue of OTR Verification will be published shortly.

Note:- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) SC/ST Candidates included in the Short List are required to produce Community Certificate(In form III/Digitally signed) issued by the Tahasildar and Candidates belonging to other reservation group should produce Non Creamy Layer Certificate issued by Village Officer , EWS candidates should produce EWS certificate issued by Village Officer at the time of OTR Verification.

Note :- (6) Copy of answer scripts of the OMR Test held on 11-07-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (7) Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER II(3)4006/2023/EW dated18/11/2023 .
