The marks secured by the last candidate in the Main list is **56.33 (Fifty Six (point) three three)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes ( and other reserved categories if any ) necessary Supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

**Note:- (4)** Candidates included in the Short List should present and produce in person the original documents for Practical Test and One Time Verification. Date,time and Venue for Practical Test and OTR Verification will be published shortly.

**Note :- (5)** Candidates included in the Short List eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009 /Community Certificate issued by the Revenue authority / EWS Certificate as per G.O.(MS)No.02/2020/P&ARD dated 12/02/2020, NOC in the prescribed format from concerned authority (for Govt. employees) shall produce the same along with the other documents at the time of OTR verification of original documents.

**Note:- (6)** The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

**Note:- (7)** According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

**Note :- (8)** Copy of answer scripts of the OMR Test held on 12/10/2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates is invalidated for the above mentioned post vide Notification No. ER VIII (1) 5131/2023/EW Dated 08/01/2024.
