NOTIFICATION

Applications are invited from qualified **Scheduled Tribe** candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after ONE TIME REGISTRATION. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010. Name of the candidate and the date of the photograph taken should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of photograph taken.

- 1 Name of Department** : Dairy Development
- 2 Name of post** : Senior Superintendent
(Special Recruitment from ST only)
- 3 Scale of pay** : ₹ 18740 – 33680
- 4 No. of Vacancy** : **01 (One)**

Note: *The above Vacancy is now in existence. The Ranked List of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from Scheduled Tribes during the pendency of the list.*

- 5 Method of Appointment** : Direct Recruitment
(Special Recruitment from Scheduled Tribes only).

Note:- *Applications received from candidates other than Scheduled Tribe will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.*

- 6 Age** : 20 – 41
Only Candidates born between 02.01.1976 and 01.01.1997 (both dates included) are eligible to apply for this post. (No other age relaxation will be allowed).

Note : *In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.*

7 Qualifications:

Candidates shall possess a degree in any discipline of a recognised university.

Probation : The candidates appointed to the post shall from the date on which he joins duty, on completion of training, be on probation for a total period of two years duty within a continuous period of three years.

Test : The candidates shall pass Manual of Office procedures and Account Test (Lower) during the period of probation. If he has not already passed same.

Training : The candidates appointed to the post shall undergo training for a period of six months at the various officers under the Dairy Development Department. The period of training shall not be reckoned for probation. The candidates will be entitled for basic pay and other allowances admissible for the post. Employees who have 10 years of ministerial service in government will be exempted from the training.

***Note:**1) Part II Rule 10(a)ii of KS&SSR regarding qualification is applicable for this selection.*

8 Mode of Submitting application:

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. **Candidates who have AADHAAR card should add, AADHAAR card as ID proof in their profile.**

prepared in pursuance of this notification subject to the conditions laid down in G.O(Ms)No.142/72/PD dated 13.04.1972, G.O (Ms)No.309/73/PD dated 29.11.1973, G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.

- 13** If a Written / OMR / Online Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
