- (iv) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. **Method of appointment** :- Direct Recruitment (From candidates belonging to Muslim, Ezhava/Thiyya/Billava, Viswakarma communities only)
6. **Age Limit** :- **18 – 39**. Only candidates born between 02.01.1978 and 01.01.1999 (both dates included) are eligible to apply for this post in the case of Muslim, Ezhava/Thiyya/Billava, Viswakarma communities . [Including the relaxation as per para 2 (i) of General Conditions].

Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile.
