**THIRD N.C.A .NOTIFICATION**

Applications are invited online only by “ONE TIME REGISTRATION” from qualified candidates belonging to Scheduled Tribe community in the State of Kerala for selection to the under mentioned post in Kerala Government service.

1. **Department** : **Collegiate Education**
2. **Name of Post** : **Lecturer in Physics**
3. **Scale of pay** : **U.G.C. Scale**
4. **Number of vacancies** : **Scheduled Tribe – 1 (One)**

**Note:-** The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above community but remains unfilled due to the paucity of candidates during the currency of the Ranked list published on 09.11.2010 for the post. This is the Third NCA notification for the post owing to non-availability of qualified candidates belonging to the above community as per the first NCA notification (Gazette date 13.05.2014, Category No. 221/14) and second NCA notification (Gazette Date. 26.07.2016, Category No. 204/16)

5. **Method of appointment** : **Direct Recruitment** (Only from candidates belonging to Scheduled Tribe Community)

**NOTE:** Applications of candidates belonging to communities other than the above will be summarily rejected. Individual rejection memo will not be sent to them.

6. **Age** : 22-45. Only candidates born between 02.01.1972 and 01.01.1995 (both dates included) are eligible to apply. [Including the relaxations in para 2 (i) of General conditions]  
**Note:-**For other conditions regarding age relaxations, see Para (2) of the general conditions except para 2(i).
7. **Qualifications**

1. Masters Degree in Physics with atleast 50% marks or its equivalent and good academic record.
2. Must have passed a Comprehensive Test in the subject concerned specifically conducted for the purpose by UGC or any agency duly constituted by the state government in this behalf. When qualifications are being equal, preference shall be given to those candidates who possess adequate knowledge in Malayalam.

Note: (i) Candidates who have obtained Ph.D Degree in the subject concerned are exempted from passing the NET examination(G.O.(P)No.86/07/H.Edn dated 19.06.2007)

(ii) For recruitment to various posts under these rules, Degrees awarded by the Universities recognized by UGC alone shall be considered.

(iii) The conditions laid down in KS & SSR part II Rule 10(a)ii are applicable.

**8 a) Mode of submitting Applications:-**

Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective post in the Notification Link to apply for the post. The Photograph uploaded should be taken after 31/12/2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is

provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, experience, community etc have to be produced as and when called for.

- 8a) **Candidate who have Aadhar Card should add Aadhar Card as ID proof in their profile**
- 9a) **Last Date of receipt of applications: 19/07/ 2017 Wednesday up to 12.00 midnight**
- b) **If a Written/OMR/Online Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.**
