## **FIFTH NCA NOTIFICATION**

Applications are invited online only under 'ONE TIME REGISTRATION SCHEME' from qualified candidates belonging to Other Christian community for selection to the under mentioned post in Kerala Government Service.

1. **Department** : **Medical Education**
2. **Name of Post** : **Senior Lecturer in ENT (Oto-Rhino Laryngology)**
3. **Scale of Pay** : **As per UGC Norms**
4. **Number of vacancy** : **Other Christian – 1**

The above vacancy is now in existence. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancy earmarked for the above community but remains unfilled due to the paucity of candidates during the currency of the Ranked List published on 26.06.2007 for the post (Category No.149/05). This is the Fifth NCA Notification for the post owing to non-availability of qualified candidates belonging to the above community as per 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> NCA Notifications as shown below:

5. **Method of Appointment** : **Direct Recruitment from candidates belonging to Other Christian. Application of candidates other than the above community will be rejected. Individual rejection memo will not be issued to such applicants.**
6. **Age Limit** : **21-49; Only candidates born between 02/01/1968 and 01/01/1996(both dates included) are eligible to apply for the post.**

**Note:-** *Members belonging to Scheduled Caste who had converted to Christianity after attaining adulthood and their children are eligible for age relaxation upto 50 years. Such candidates should be born between 02.01.1967 and 01.01.1996 (both dates included).*

[Including the relaxation as per para 2(i) of the General Conditions]

(For other conditions regarding age relaxation please see para 2 of the General Conditions except para 2 (i))

**Qualifications: Senior Lecturer**

- (i) Post Graduate Degree in the respective discipline from a recognised University (viz.MD/MS/DNB)
- (ii) Permanent Registration under State Medical Council (Travancore Cochin Medical Council)

***In the absence of candidates with the above qualification, candidates with***

- (i) MBBS Degree from a recognised University
- (ii) Permanent Registration under State Medical Council (Travancore Cochin Medical Council)

***-will be considered for the post of Lecturer (salary as per UGC Norms)***

**NOTE:**

1. *Rule 10 (a) ii of Part II of KS&SSR is applicable.*
2. *Above qualifications must be acquired on or before the last date of receipt of application*
3. *Provisional Registration with any Medical Council will not be accepted.*
4. *Those who are appointed in the post should serve for four (4) years during the first ten (10) years of their service (including the period of training) anywhere in India or any other foreign country under defence services connected with defence, if required. Those who have completed 45 years of age are exempted from the above compulsory Military service.*

**8. Mode of submitting applications:**

- a) Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to applying for a post. The Photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password.

Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for.

- b) If a Written/OMR/Online Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
- c) Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.
