Applications are invited from qualified **Scheduled Tribe** candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after **ONE TIME REGISTRATION**. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010. Name of the candidate and the date of the photograph taken should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of photograph taken.

Note: (i) *TheName, Educational qualification and age for this post is notified as per GO(P) No.264/10/TD dated 10.11.2010 (SRO No.1025/10) and GO(P)No.178/2015/TD dated 03.10.2015 (SRO NO.669/15).*

(ii) *The above Vacancies are now in existence. The Ranked List published by Commission in Wayanad District shall cease to be in force after one year from the date of finalisation of the Ranked List or after one month from the date of commencement of training in respect of the last batch advised from the Ranked List within a period of one year from the date of finalisation of the Ranked List whichever is later. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from candidates belonging to Scheduled Tribes, during the currency of the list.*

(iii) *The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27/05/1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he or she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O.(MS) No. 4/61/PD dated 02/01/1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this*

post, but they can apply to higher posts when notified.

- iv) In the case of Direct Recruitment preference shall be given to Ex-servicemen.*
- v) Civil Excise Officer (Trainee) shall not be appointed in the substantive post till the successful completion of basic training for a period of not less than six months, subject to the minimum of 180 working days as may be decided by the Commissioner of Excise. Persons undergoing basic training shall be paid stipend as may be fixed by the Government from time to time. All the persons who did not undergo basic training will be placed under orders of training within a period of two years and those who did not successfully complete the basic training shall not be considered for future promotion.*
- vi) NCC cadets having "A", "B" & "C" Certificates will be given weightage marks at the rate of 2%, 3% and 5% respectively.*

5 Method of Appointment : Direct Recruitment
(Special Recruitment – Candidates belonging Scheduled Tribes)

Note:- *Applications received from candidates other than Scheduled Tribe will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.*

6 Age : 19-36, Only Candidates born between 02.01.1981 and 01.01.1998 (both dates included) are eligible to apply for this post. No other relaxation will be allowed.

7 Qualifications:

1) Educational Qualification:

Must have passed the Plus Two examination or its equivalent.

Note: Rule 10 (a) ii of KS&SSR is applicable.

2) Physical: Height-A minimum of 160 cms (relaxation upto 155 cms), Chest-A minimum of 76 cms around the chest and must have an expansion of 5 cms on full inhalation.

3) Physique and Eye Sight

(i) Must be certified by a Medical Officer not below the rank of an Assistant Surgeon as to his physique fitness and capacity for active outdoor work. The Medical Certificate has to be produced as and when called for.

(ii) Must be certified to possess the visual standards specified below without glasses.

Note:-

(i) *Each eye must have a full field of vision. Colour blindness, squint or any morbid conditions of the Eye or lids of either eye will be deemed to be a disqualification.*

(ii) *Must be free from apparent physical defects like Knock-knee, Flat Foot, Varicose Vein, Bow legs, Deformed limbs, irregular and protruding tooth, Defective speech and hearing. Candidates should produce a medical certificate in original in the form prescribed hereunder certifying to their physical fitness and eye sight without glass at the time of Physical Efficiency Test / Endurance Test. Medical Certificate should be one obtained from a Medical Officer under the Government not below the rank of an Assistant Surgeon / Junior Consultant. This Medical Certificate shall be uploaded in the profile of the candidate and the original shall be produced at the time of certificate verification.*

Note:- Details regarding standards of vision should be clearly stated in the Certificate as given above and vague statement such as Vision "Normal", "Average", etc will not be

accepted. Specification for each eye should be stated separately. If the specification are not as indicated above, the officers issuing the Certificate should certify whether the candidate has got better standards of vision or worse standards of vision as the case may be, otherwise the certificate will not be accepted

4) **Physical Efficiency Test**

All the male candidates must qualify in any of the **Five (5)** events out of the Eight events specified below of the National Physical Efficiency one star standard test.

Note:- Physical Measurement of candidate will be taken prior to the physical efficiency test and those who do not possess the prescribed physical measurement at that time will not be admitted for the Physical Efficiency Test. If accidents or injuries happen to a candidate while participating in the Physical Efficiency Test / Endurance Test, he/she will not be given further chance to participate in the Test.

5) **Endurance Test :**

Candidates must have qualified in the endurance test of 2 kms within in 13 minutes.

8 **Mode of Submitting application:**

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and

when called for. **Candidates who have AADHAAR card should add, AADHAAR card as ID proof in their profile.**

- 12** Appointments are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
- 13** If a Written/OMR/Online Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket 15 days prior to the examination will alone be permitted to attend the examination.
