FIRST NCA NOTIFICATION

Applications are invited through 'One Time Registration' facility exclusively from the candidates belonging to the following reservation communities of Kerala state for appointment in the under mentioned post in Kerala Government Service.

- 1. Department** : Animal Husbandry
- 2. Name of Post** : Live Stock Inspector Gr. II/Poultry Assistant/Milk Recorder/
Store Keeper/Enumerator
- 3. Scale of Pay** : Rs. 10,480 – 18,300/-
- 4. Number of Vacancies** : District Wise

Note: (i) Applications submitted by candidates other than those belonging to the above communities will be summarily rejected. No rejection memo will be issued.

(ii) Separate Ranked lists will be prepared for above mentioned communities in concerned districts in pursuance of this notification. The Ranked Lists thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above mentioned community but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the above post in the date undermentioned below.

(iii) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O. (Ms) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another District unless he/she completes 5 years continuous service from the date of commencement of service in the former District. Even if transfer is allowed after 5 years, it will be subject to the rules in G.O.(P)No.36/91/P&ARD dated 02.12.1991. But as per G.O(P)12/96/P&ARD dated 16.03.1996, the condition of 5 years service is not applicable for the transfer to the Districts of Idukki, Wayanad and Kasaragod. This concession will be available only for getting transfer into these districts, but not for getting transfer out of these districts and this concession will be granted only once in the career of a Government Servant. Candidates already in Government Service holding the post in any one district are prohibited from applying for the same post in another District, but they can apply to higher posts when notified.

5. Method of Appointment : Direct Recruitment (From qualified candidates belonging to above mentioned reservation communities only)

Note: - (1) Candidates recruited by the Commission shall be appointed to the service provisionally and they shall undergo the Stockman training course/Livestock Inspector training course. After the successful completion of training, their provisional appointment will be regularized from the date of first appointment treating their training period as regular service. Those who do not complete the course successfully in the first attempt shall be allowed three more chances to complete the course successfully. In the case of candidates who fail to complete the course successfully even in the fourth attempt, their provisional appointment shall be terminated and they shall be discharged from service.

There shall be no re-ranking of candidates based on the marks secured by them during the training.

(2) Candidates selected will have to execute a bond in the prescribed form to serve the Government of Kerala for a minimum period of 5 years after the regular appointment. Those who leave the service in between or during training are liable to pay for the damage if any fixed by the Government.

(3) Each trainee will have to produce a certificate (in original) of Physical Fitness from a Medical Officer not below the rank of an Assistant Surgeon as and when called for by the Commission.

6. Age Limit : (i) For SIUC Nadar, Dheevara, Hindu Nadar Communities

18 – 39 . Only candidates born between 02.01.1976 and 01.01.1997 (both dates included) are eligible to apply for the post. (including the relaxation as per para 2(i) of General Conditions

(ii) For Scheduled Tribe

18 – 41 . Only candidates born between 02.01.1974 and 01.01.1997 (both dates included) are eligible to apply for the post. including the relaxation as per para 2(i) of General Conditions

[For concessions allowed in upper age limit please see para (2) of the general condition under part II of this Notification, except para 2(i)]

7. Qualifications:-

(1) A pass in VHSE with Live Stock Management as main subject.

Note:- 1) Differently abled candidates are not eligible for appointment to the post.

2) KS&SSR Part II Rule 10(a)(ii) is applicable

8. Last date for receipt of Application: 30.12.2015, Wednesday upto 12.00 Midnight.

9. Mode of Submitting Applications:-

Candidates shall register as per 'ONE TIME REGISTRATION ' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for applying for a post. The photograph uploaded should be taken on or after 31-12-2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10

years from the date of uploading. There is no change in other instruction regarding the uploading of photograph. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile. They must quote the User- ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove qualification, community, age etc. have to be produced as and when called for.
